## **SUMMARY ANNUAL REPORT FOR MCASF LOCAL 725 DEFINED CONTRIBUTION RETIREMENT TRUST FUND**

This is a summary of the annual report for the MCASF Local 725 Defined Contribution Retirement Trust Fund (Employer Identification Number 58-2490173, Plan Number 003) for the plan year 01/01/2020 through 12/31/2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Basic Financial Statement**

Benefits under the plan are provided by a trust fund. Plan expenses were \$1,189,419. These expenses included \$370,973 in administrative expenses and \$818,446 in benefits paid to participants and beneficiaries. A total of 1,412 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$54,928,614 as of the end of the plan year, compared to \$48,180,844 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$6,747,770. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$7,937,189, including employer contributions of \$1,489,375, employee contributions of \$922,598, gains/(losses) of \$6,488 from the sale of assets, and earnings from investments of \$5,518,728.

5. Fiduciary information, including non-exempt transactions between the plan and parties-in-interest (that is, persons who have certain relationships with the plan).

### **Paperwork Reduction Act Statement**
